Submission Terms and Regulations

Submissions intake is the Friday prior to the show from 10 a.m. - noon. Submissions may be left with the Elfrida Art Center prior to the intake day, if prior arrangements are made. Entries must be prepared for hanging. Any entries not properly prepared will not be accepted. All items must be picked up between 4 and 5 p.m. the day of the show. Items may be retrieved from the Elfrida Art Center the following Friday or Saturday, if prior arrangements are made. Judging will take place on Friday from 1 - 3 p.m. The show will open to the public on Saturday at 9 a.m. and will close at 4 p.m. **Limit 3 entries per person.**

Entry fees are:

Under 16 and non-professional \$3.00 per entry

Adult/Professional (anyone who has previously sold any works) \$5.00 per entry

A fee of 25% of any and all sales as a result of this show will be retained by Elfrida Art Center, Inc.

All entrants will receive a 20% discount coupon from Desert Videoland Oasis upon payment of entry fee.

The following classes and divisions will be accepted for judging:

Class	Division
A 2-Dimensional	Water Color, Oil, Acrylic, Pastel, Pencil/Graphite, Mixed Media
B 3-Dimensional	Fiber, Ceramic, Leather, other
C Photography	Printed, matted and/or framed
